Vero Beach Karate Association Camp Policy and Information

Welcome to the Vero Beach Karate Association Summer Camp! We believe that the martial arts activity can be a wonderfully exciting activity for children. In addition to the personal rewards of learning self defense skills, there are significant health benefits and many character building rewards. We also believe that we are in partnership with parents and teachers to help children develop into strong, capable citizens with high ideals. Much of our personal development and character building instruction happens during our camps along with our music and dance lessons. We hope you will enjoy seeing the results of all this at one of the demonstrations after each camp session.

Some information and policies that you need to know before camp begins:

Lunch: Each camper must bring their own bag lunch. If you use a lunchbox please make sure it is marked with the camper's name. Please use cold packs for perishable items. We do have snacks and drinks available for purchase at our school store. A snack account card can be purchased if you do not want your camper to carry their money with them. Please help your child to understand that he/she is responsible for their own money if they do not use a snack account.

Medications: Any medications that the camper might need must be turned in at the school store. All medications must be in their original containers with labels attached, directions and name clearly marked.

Dress Code: Although we train in the martial arts 3 times a week, campers are not required to wear a uniform (gi) unless they train with our association regularly. If this is an activity that you and your child feel they will continue during the school year then you may purchase one at the school store.

Guys:

Shirts at all times

Belts must be worn with all oversized pants

Girls:

Modest shirts and shorts (no halters, midriiffs or cami's)

No "mini skirts"

V.B.K.A. will not be responsible for any valuables brought to camp.

Behavior: We are here to provide your child with a wholesome summer experience that will teach them lifelong skills for many areas of their life. To be able to do this we need each camper to understand what behavior is expected of them. We will not tolerate foul language, inappropriate gestures or remarks, bullying or *disrespect of authority*. Counselors will do their best to deal with campers in a firm but loving way. Should the camper refuse to acknowledge the authority of the staff member or become a repetitive problem, the camper will have to talk to the Head Instructor. If the camper has repeated problems the parents will be called and disciplinary action will be agreed upon. If necessary, the camper will be sent home. There is no refund for campers sent home for behavioral problems.

Payment: Camp payments may be made weekly by cash, check, debit or credit. (Visa/MC/Discover) Payment is due the beginning of the week, if you need to pay at the end of the week please inform the Camp Director. If the camper's last name is different from the last name on your check, please put camper's name on the memo line. There is a returned check fee of \$10.00. There are no discounts for days missed. There is no refund or credit if camper goes home sick or if camper is sent home for behavioral reasons.
